





From 2000 to 2003, James was employed as a third-party consultant inspector/plans examiner representing 12 municipalities across 5 counties in the Chicagoland area. James' focus on the study of model codes has led to his 34 International Code Council certifications, including Master Code Professional, Chief Building Official and Certified Fire Marshal credentials. Before joining the City of Knoxville, James held an unlimited industrial, commercial and residential electrical contractors license in the State of Illinois and served as the President of the International Association of Electrical Inspectors, 961 Suburban Chicago Division from 2003 to 2015.

## **ABOUT THIS COURSE**

The City of Knoxville Plans Review and Inspections team will give an overview of the significant changes related to the transition from the 2018 to 2024 I-Codes focusing on the IBC, IEBC, IECC, IRC and A117.1-2017 standards.

## **HSW JUSTIFICATION**

Participation in this course, presented by the Chief Building Official, on Significant code changes from the 2018 to the 2024 IBC Code Family provides attendees with a road map to understand where changes to the code will be most impactful. Understanding these updates directly impacts the safety and well-being of the public. Building codes are essential to ensuring structures are designed and constructed to meet current safety standards, address new environmental concerns, and incorporate advances in technology. By staying informed on these changes, Architects, Engineers, and Contractors can design and construct buildings that are safer, more resilient, and compliant with up-to-date regulations, protecting the health, safety, and welfare of building occupants and the public at large.



## **LEARNING OBJECTIVES**

- 1. Upon completion of this course, participants will be able to identify significant code changes to chapter 5 including horizontal building separations, new requirements in chapter 6 for mass timber construction, and a number of changes in chapter 7 and chapter 9 regarding fire and smoke protection and life safety measures.
- 2. Participants will understand the significance of accessibility changes related to new and existing buildings.
- 3. Participants will understand how to design and build structures that meet current safety standards, address new environmental concerns, and incorporate advances in technology.
- 4. The presentation will conclude with a discussion of the adoption, by the City of Knoxville, of the 2024 I-Codes in January of 2025, and how this code adoption relates to Plans Review, Permitting and Inspections. The discussion will be centered on changes to definitions in IBC chapter 2 that specifically impact projects that are typical in our area including: Duties and Powers of the Building Official, Change of Occupancy, and High-Rise Buildings.

## What I Learned from CSI... It's not the Heat... It's the Relative Humidity

It was a late afternoon call from a convenience store owner which prompted a site visit from our office. The maintenance staff had visited the store to change HVAC air filters and found several product glass doors sweating. We found the air conditioning system thermostat setting at 65°, ice cream freezer at 5°, the beer cave cooler doors were sweating with a broken gasket. Condensation on the glass door surface prevented customers from making their selections before opening the doors. We have all been to the grocery store and selected our items before opening the cooler/freezer doors. Many of these grocery coolers and freezers have integral door frame heaters that reduce condensation after the doors are opened and closed. Many grocery store deli meat cases have fans that blow air flow across the glass surface to prevent condensation. The issue at the convenience store was that with all the high temperatures recently, the store personnel had lowered the thermostat setting from the normal 70°F setting to 65°F. This raised the relative humidity which resulted in more moisture content in the air. Then we had several days of significant rainfall after the heat wave. The flat roof membrane had several roof leaks which contributed to the problem. The number of customers entering and exiting out of the front doors did not help moisture content in the air either.

The HVAC units were originally specified as 8 ton capacity units, but 10 ton units were installed due to supply chain issues. One of the HVAC units was short cycling and the unit was not de-humidifying correctly. Condensate drain arrangement is suspect and if the

drain pan is not emptying, the condensate could be reevaporating into the airstream...

There is a solution: HVAC balance report to ensure the building is not negative air pressure from rangehood, add electric reheat to the HVAC system, add hot gas refrigerant reheat, install a Rawal valve, https://www.rawal.com/

Other indicators of high RH: Curling paperback book covers, framed artwork ripples, paper sticking and/or misfeeding in printers, cash register tape not feeding correctly

RH analogies: Frost free freezers, automobile defrosters, morning dew on your car, fogged up house sliding glass door in winter time, steaming road surfaces after a summer rain

## Google AI:

Relative humidity (RH) is the amount of water vapor in the air compared to the maximum amount that can exist at a given temperature. As temperature increases, air can

hold more water vapor, so RH decreases. Conversely, as temperature decreases, air becomes wetter and RH increases. This relationship is inversely proportional.



## WHY SHOULD YOU TAKE THE CDT?

Working in the construction industry requires a constant influx of knowledge and a high level of performance. Communication is key to successful projects throughout the design and construction phases, but it is incredibly critical between the key parties, typically the owner, designer, and contractor. If anyone is looking to boost their communication skills and realize further success in their projects' execution, the CDT (construction document technologist) certification is an excellent start to routing success.

The CDT is a certification that boasts one's ability to communicate construction documents effectively. This is a certification worth having on your resume and after your name, but it is so much more. Studying for the CDT exam is nothing minor, and the knowledge you gain from this exam will greatly impact your performance. The PDPG (project delivery practice guide) is a single source to everything you need to know for the CDT and is also a recommended supplementary resource for the ARE's Project Management exam, proving its inherent value to understanding how to project manage in the construction industry.

While studying the PDPG in preparation for the CDT, I immediately saw a transformation in my work performance. It first was subtle but very relevant. The terms and phrases coworkers and contractors used made sense. The context was there, but now I understood the deeper meaning, what needed to be done, and when things did not belong. I began to understand the value of specifications, how division 0 impacts biddings, and how the project manual acts like a field guide throughout the construction phase of a project. By the time I took the CDT, and succinctly passed, I could assist with writing, reading, and analyzing specifications, follow along and contribute to OAC meetings, properly coordinate

submittals and RFI's, and perform quality assurance to prevent conflict and problems from arising.

What are the most critical lessons the CDT can provide, and is it worth it? The four C's of the CDT, clear, concise, correct, and complete, are inherent throughout the entire process of developing specifications and drawings. The PDPG explains in depth how these four principles apply throughout the 8 domains of a project from specific tasks to overall considerations. If there is anything to take away from the CDT, it is that construction documents must be clear, concise, correct, and complete. With this, a project will more likely have less bumps along the way, creating a decrease in cost and time dealing with problems that could have been avoided. So studying for the CDT can produce real savings in the long run, and in the short term, it provides a certification bolstering the proof that you are well informed and able to tackle the plethora of



tasks the construction industry hosts.

I am thankful to many CSI members for encouraging me to taking the CDT and guiding me along the way. Mike Young, FCSI, CDT, CCS, CCCA and Mark Ogg, CSI, CCCA, CD, PMP were particularly encouraging in showing me how critical the CDT was to growing in my career. My local CSI chapter members and coworkers, Kathryn (Fuller) Richardson and Stacy Colbaugh shared their enthusiasm, advice, and study resources. 
