

### What I Learned From CSI... A Pizza Oven Story

What is one food that most of us will always eat, even if we are on a diet? If you answered pizza, that is one food that can be prepared in several different types of ovens. Some of us might remember the soggy pizza served in your school cafeteria. The frozen pizza from your school cafeteria was probably baked in a convection oven on several cookie sheets full of pizza to keep up with the serving line demand. Whether you purchase your pizza from the frozen food section of your grocery store, a single slice at a convenience store, or a pizza restaurant, there are several different methods to bake a pizza. According to pizza aficionado's, pizza is best baked at 800 degrees because the hotter the oven, the

better the final product. The convection oven used in school cafeterias produces a less than ideal product, but grade school students are less likely to complain to management. The school convection ovens are often installed with other cooking equipment under the grease capture type II hood. There is the old-fashioned pizza deck oven (400-600 degrees) where the pizza is inserted with a pizza peel tool. We have all probably noticed Pizza Hut, Domino's, or a Little Caesars conveyor type pizza oven (400-600 degrees). A recent development is a brick dome wood fired pizza oven that bakes pizza in a very fast manner because it bakes at about 800 degrees. Almost all pizza ovens are available in electric, gas fired or even wood/coal fired models. Most pizza ovens require a different type of range hood. The old-fashioned pizza deck oven can be furnished with a type 2 heat capture hood which does not require a fire extinguishing system. The conveyor oven sometimes requires a type 1 range hood with an integral fire suppression system because the open inlet and outlet can allow a pizza to overcook and flare up out of control. The brick dome ovens often require a type 1 Hood with fire suppression because of the extreme temperatures.

The 2018 International Mechanical Code section 507.2 details the type of hoods for different pizza ovens. Many of the pizza restaurant franchises have specific types of ovens and hoods which they require as part of their design criteria.

We recently had a convenience store owner who wanted to include pizza in their food menu. The owner visualized a small pizza oven on one of the Back Of House (BOH) counters. The owner was not aware that different franchises have certain requirements. Hunt Brothers Pizza, who specializes in convenience store market, requires the use of a conveyor oven that they approve. Obviously a 12" personal size pizza oven requires less space than an 18" or 24" pizza oven. The owner ultimately decided on the personal pizza size conveyor oven because of the space limitations.
